

2010 Plan year #1002 summary of dental benefits

Group Health’s Clear Care Plans

Your dental plan

Oral health is an important part of your overall health. Group Health* has partnered with the Washington Dental Service (WDS) PPO Program to offer you this dental plan as part of your complete Clear Care plan when you choose dental benefits. The dental plan is designed to provide you with full coverage for your semiannual dental checkups when you see a PPO provider so that dental health problems can be detected early.

Plan benefits

The summary below outlines the coverage areas and the percentage of coverage that applies. This program will pay a maximum of \$1,500 in covered benefits for each covered person in any calendar year. A \$100 annual deductible is applicable to everything except preventive dental care. There is a monthly \$48 premium in addition to the plan premium each month.

This plan includes the services in Class I, Class II, and Class III for a combined annual benefit of \$1,500.

The following chart is a list of your covered services according to type of service and cost share.**

How to use your Washington Dental Service plan

Your dental care program through WDS gives you the freedom to use any dentist in Washington. Using this plan is very simple. Give your dentist your social security number and your plan number, which is #1002 for Group Health Options, Inc. This information will be used to submit claim forms.

Group Health's Clear Care PPO plan members are eligible to enroll in the Washington Dental Service (WDS) PPO program with slightly better benefits if you see a PPO dental provider. This WDS dental plan gives you the freedom to use any dentist. Check with your dentist to see if they are part of the PPO network. The plan will pay a maximum of \$1,500 in covered benefits in any calendar year. If you seek treatment from a WDS dentist, your dentist will submit claim forms, and WDS's payment will be made directly to your dentist based on the dentist's pre-approved fees.

You are only responsible for ensuring that your dentist completes and mails claim forms to WDS. More than 90 percent of the dentists in Washington State are WDS participants. If you receive treatment from a dentist who is not a participant of WDS, you will be responsible for submitting the claim form. Payment will be based on actual charges or maximum allowable fees for nonparticipating dentists, whichever is less.
